**Reason for amendment:**

The applicant applied to change the layout of the facility to establish an optimal distribution of turbines for a balanced output capacity between the three wind farms and this required that some turbines be included or excluded from the respective wind farms. The boundary changes do not result in an increase in the authorised development footprint, nor the total number of turbines across the wind farm. There is also no change in the energy production capacity of the wind farm.




